Petition of Division of Public Utilities for extension of 120 days to complete review

ISSUES:

On September 30, 2008, the Division of Public Utilities (“Division”) petitioned the Utah Public Service Commission (“Commission”) to initiate a review of various telecommunications service provider’ tariffs and exchange maps to bring them into compliance with Commission rules. Accordingly, the Commission opened the above dockets for each Company to review its tariffs and exchange maps.

The Division has received tariff information and proposed tariff maps for most of the above Companies and at the present time is in the process of reviewing and making suggestions for

updates. To date, one company, Beehive Telephone, has filed revised tariff sheets and maps to meet the February 13, 2009 complete date. Another company, Direct Communications Cedar Valley, is about to file their revision. The Division underestimated the time required to review all the Companies' tariffs and exchange maps.

The Division therefore requests that the Commission extend the completion date 120 days to June 13, 2009 to give the Division more time to complete the tariff reviews.
