The Company shall provide notice of the hearing and public witness portion of the hearing to its customers no later than 15 days before the hearing.

Discovery turn around time is 14 calendar days for requests filed before February 17, 2010 and 10 calendar days for those filed on or after February 17, 2010. For requests served before February 17, 2010, the parties may agree to amend the turn around time as needed.
