The Office<sup>1</sup> is authorized to assess the impact of utility rate changes and *other regulatory actions* related to Bresnan and UBTA-UBET as applicable public utilities, on residential and small commercial utility consumers, and to advocate positions most advantageous to these consumers. The Office was a party to Docket No. 07-2476-01, Bresnan’s application for a certificate of public convenience and necessity to provide public telecommunications services within the Vernal exchange in and around Vernal, Utah. The Office monitored the proceedings in Docket No. 08-2476-02 pertaining to the interconnection agreement between Bresnan and UBTA-UBET that is at issue in this complaint. Parties to this docket provided pleadings to the Office’s counsel. The Office is familiar with the Commission’s orders that determined the terms and conditions of the

interconnection agreement. The interconnection agreement as ordered by the Commission and the outcome of Bresnan's complaint directly affect and implicate the availability and rates for telephone service to residential and small commercial utility consumers in the Vernal exchange.
