The sole purpose of TracFone's August 13 Notice of Expanded Lifeline Offering was to place on the record of this proceeding and to inform all parties of the changes to TracFone's Lifeline plans which were announced in all states where TracFone has been designated as an Eligible Telecommunications Carrier or where it has petitioned for designation as an ETC on the same day. Nothing in that filing modifies TracFone's position regarding the applicability of any requirements governing the Utah State Universal Service Fund or the 911 surcharge.
