3 THE COURT: This is In the Matter of the
4 Merger and Transfer of Control of Global Crossing
5 Telemanagement, Inc. to Global Crossing Local
6 Services, Inc., Docket No. 10-2246-01.

7 I'm Ruben Arredondo, the ALJ assigned to hear
8 this matter. Let's take appearances, beginning with
9 the Division.

10 MS. SCHMID: Patricia E. Schmid, with the
11 Attorney General's Office, representing the Division
12 of Public Utilities. And with me for the Division is
13 Ronald Slusher.

14 THE COURT: Okay, thank you.

15 And then on the phone, again, if you could
16 just state who you are. Your name and who you're

12 We -- you submitted notice of this transfer.
13 There hasn't been any opposition filed. And so with
14 that, Ms. Schmid, would you proffer that your
15 witness's testimony -- or recommendation would be the
16 same as filed, I think it's August 12, 2010, for
17 approval of this merger?

18 MS. SCHMID: Yes, I will so proffer.

19 THE COURT: Thank you.

20 And anything you'd like to add, Ms. Norton,
21 Ms. Peters, or Mr. Price? Would your application
22 remain the same?

23 MS. NORTON: Yes, it does.

24 THE COURT: All right. Then with that, we'll
25 assume that the approval of this merger is in the

1 public interest. And we will issue an order
2 shortly -- I will issue an order shortly recommending
3 the Commissioners approve this transfer.

4 Anything else anyone would like to add?

5 MS. SCHMID: Nothing.

6 THE COURT: All right. Thank you very much.

7 MS. NORTON: Thank you, sir.
