By The Commission:

The Commission held a technical conference in the above-entitled matter on September 24, 2012. At the conference, the Department of Workforce Services (“DWS”) presented information on the eRep system discussed in the Division of Public Utilities’ (“Division”) memo, filed with the Commission on September 10, 2012. The conference participants discussed the need for a “draft” business proposal outlining the business requirements DWS will incorporate into its eRep system concerning the Lifeline program and agreed upon the following additional schedule for this docket:

1. **Monday, October 1, 2012** – The Division will file a “draft” business proposal outlining the business requirements DWS will incorporate into its eRep system concerning the Lifeline program. Before the Division files its draft, the Division will email to and incorporate comments from parties on the telecom service list. Any other party desiring to receive the Division’s draft may receive it by contacting the Division not later than September 28, 2012.
2. **Wednesday, October 3, 2012** – Parties may file comments on the Division’s draft.
