Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Petitioner TracFone Wireless, Inc. (“TracFone”) hereby petitions for leave to intervene in this docket.

In support of this petition, Petitioner states as follows:

1. Petitioner has been designated by the Utah Public Service Commission as an Eligible Telecommunications Carrier in the State of Utah for the limited purpose of offering lifeline service to qualified households, subject to a determination in this docket of reasonable fees for utilization of the Department of Community and Culture’s eligibility verification database.

2. The legal rights and interests of Petitioner may be substantially affected by this proceeding. Moreover, the Commission determined in its Report and Order dated September 13, 2010, in Docket 09-2511-01, that TracFone “shall have a right to intervene in [this] docket.”

3. Petitioner has not fully determined the specific positions it will take or the relief it will seek. Petitioner seeks to intervene for purposes of protecting its interests as they may appear.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
