All West Communications, Inc. (“All West”) and the Division of Public Utilities (“Division”), hereby jointly request a suspension of the Scheduling Order in this Docket pending consideration of the Partial Stipulation to be submitted by the Parties. The Parties are in the process of completing a Confidential Stipulation that resolves most, but not all, of the issues raised in All West’s Application. Specifically, the parties seek to reserve two distinct issues related to depreciation expense for hearing: 1) normalization of depreciation; and 2) the appropriate application of approved depreciation rates under group asset accounting to include

treatment of fully depreciated accounts. The Parties will file the Confidential Stipulation on or before September 30, 2011.

The Parties request that the Scheduling Order in this case be suspended until such time as the Public Service Commission has reviewed, considered, and issued an Order on the Stipulation since approval of the Stipulation will considerably narrow the focus of the Hearing. Further, suspension of the existing Scheduling Order will allow the Parties sufficient time to finalize the Stipulation. If the Stipulation is approved, a modified schedule for this docket may be adopted and the parties can focus the testimony on the remaining issues, rather than filing testimony on all issues in the case. Additionally, adoption of the Stipulation will expedite resolution of this docket as well as reduce the time and expense incurred by the Commission, the Division and All West.
