The Utah Office of Consumer Services moves the Commission to order that the Transcript for Hearing Proceedings for the October 11, 2011 hearing in this docket, be designated as public. This motion is based upon the following statement.

1. The October 11, 2011 hearing is presumed to be public under *Utah Admin. Code R. 746-100-10(E)(1)* (2011). There is no record that any part of the hearing was closed to the public “for the presentation of proprietary, trade secret or confidential material.” *Id.*
2. There is no record that any party requested the hearing be other than public or that any party requested that the transcript be confidential. There is no record that the Commission considered any fact or circumstance that would compel all or any part of the transcript to be confidential.

3. While the stipulation considered at the hearing contained confidential information and was filed with the Commission in both confidential and non-confidential redacted forms, there is no confidential information cited or referred to in the transcript.

The Office intends to file a motion to amend the October 20, 2011 Interim Order Approving Confidential Stipulation, to correct procedural and substantive error pertaining to the Office and the Office's statutory mandate. To conform its motion to the Commission's procedural rules and the Utah Government Records Access and Management Act, it will be necessary that the Office disclose the transcript as a public record.
