On August 15, 2011, PAETEC Holding Corp. (“PAETEC”), PaeTec Communications, Inc. (“PCI”), McLeodUSA Telecommunications Services, LLC (“McLeodUSA”), (collectively, “PAETEC Regulated Entities”) and Windstream Corporation (“Windstream”), (collectively, the “Applicants”) filed an application for Approval of the Indirect Transfer of Control of PAETEC Regulated Entities to Windstream. Applicants seek informal adjudication of the application pursuant to Utah Administrative Code R746-349-7.
