On January 11, 2012, NextG Networks of California, Inc. (“NextG-CA”), NextG Networks, Inc. (“NextG Networks”), and Crown Castle Solutions Corp. (“Solutions”) (collectively, “Applicants”) filed an application for Commission approval to complete a transaction involving the transfer of indirect control of NextG-CA to Solutions. Applicant seeks informal adjudication of the application pursuant to Utah Administrative Code R746-349-7.
