Dear Mr. Widerburg,

Liberty-Bell Telecom, LLC ("Company") notifies the Utah Public Service Commission that it is changing its name to dishNET Wireline L.L.C. ("dishNET"). At the same time, it will cease doing business as "DISH Network Phone & Internet." For legacy customers receiving services solely under the Liberty-Bell name, dishNet Wireline L.L.C. will adopt the trade name "Liberty Bell Telecom." These changes will take effect on May 21, 2012.

The Company was granted authority to provide facilities-based and resold local and interexchange services in Docket No. 09-2509-01. If the Commission issues new certificates, the name should appear as "dishNET Wireline L.L.C."

This change is not the result of a corporate reorganization or change of control. There will be no change in operations or to customers who will receive notice of the name change.

The original and five copies are enclosed of this letter as well documentation from the Utah Department of Commerce reflecting the changes in name and registration of the trade name. An electronic copy has been submitted to psc@utah.gov.
