Budget PrePay, Inc. d/b/a Budget Mobile (“Budget” or the “Company”), by its undersigned attorneys, respectfully submits this motion to modify the caption in this docket. In its original petition, Budget inadvertently misidentified its d/b/a as “Budget Phone, Inc.” Budget indeed does business under the name Budget Phone; however, that d/b/a is used for Budget’s landline services. Budget Mobile is the d/b/a used by Budget for its wireless services. Therefore, since this petition is for Budget’s wireless operations, the correct d/b/a is “Budget Mobile.” Secondly, the word “PrePay” in the name should have two capital “P’s”. Therefore, to

avoid any confusion with regard to the entity seeking ETC authority, Budget respectfully requests that the Commission modify the caption to this proceeding as follows:

In the Matter of Budget ~~Prepay~~ **PrePay**, Inc. d/b/a Budget ~~Phone, Inc.~~ **Mobile's** Petition for Limited Designation as a Non-Rural Wireless Eligible Telecommunications Carrier

Such that the corrected caption reads:
