NOTICE

On September 28, 2012, TCG Utah (“TCG”) and Teleport Communications America, LLC (“TCA”), (collectively, “the AT&T companies” or “Applicants”) filed a joint application seeking Commission approval of TCA to operate as a Competitive Local Exchange Carrier (“CLEC”) under a Certificate of Public Convenience and Necessary (“CPCN”), and for Commission approval to merge TCG into TCA. Applicants seek informal adjudication of the merger application pursuant to Utah Administrative Code R746-349-7.

In accordance with R746-349-7 of the Utah Administrative Code, the Commission hereby gives notice that the application for merger has been filed, that any interested party may submit comments on the application within 14 days following this notice, and may submit reply comments within 21 days following this notice.

A hearing on the application is scheduled for **Friday, November 16, 2012, at 9:00 A.M. (MST), Fourth Floor Hearing Room 451**, Heber M. Wells State Office Building, 160 East 300 South, Salt Lake City, Utah. The hearing will be conducted by the Administrative Law Judge for the Commission. Parties not appearing *pro se* may be represented by local

counsel, joined by local counsel, or otherwise admitted to practice in Utah by a motion *pro hac vice* pursuant to Commission rules (Utah Admin. Code R746-100-6(B)). Attorneys seeking *pro hac vice* admission may wish to read the “Notice to Attorneys Licensed in Foreign State,” which can be viewed on the Commission’s Web site at <http://www.psc.utah.gov/otherlinks.html>.

Individuals wishing to participate by telephone should contact the Commission at least two days in advance by calling (801) 530-6716 or call toll free 1-866-PSC-UTAH (1-866-772-8824). Participants attending by telephone should then call the Commission at one of the numbers posted above at least five minutes before the beginning of the hearing to ensure participation.
