MOTION FOR APPROVAL OF UTAH POLE ATTACHMENT AGREEMENT BETWEEN QWEST CORPORATION AND GOOGLE FIBER UTAH, LLC

Qwest Corporation d/b/a CenturyLink QC ("CenturyLink") respectfully submits the attached Utah Pole Attachment Agreement ("Agreement") between CenturyLink and Google Fiber Utah, LLC ("Google") for the Public Service Commission's review and approval under Utah Admin. Code R746-345-3.

On August 28, 2006, the Commission approved CenturyLink's existing standard pole attachment agreement in this docket. CenturyLink's standard pole attachment agreement is known at the "Safe Harbor" agreement. The Agreement between CenturyLink and Google is very similar to the existing Safe Harbor with a few exceptions. A copy of the Agreement in

redlined format showing the differences between it and the Safe Harbor is attached as Exhibit 1.²
An executed copy of the Agreement is attached as Exhibit 2.

Most of the distinctions between the Agreement and the Safe Harbor reflect changes that the Commission recently approved in Docket No. 10-035-97 with respect to Rocky Mountain Power Company's Safe Harbor agreement.³ CenturyLink is in the process of preparing an application to make changes to its Safe Harbor agreement consistent with the Commission's actions in Docket No. 10-035-97. In an effort to have the Google Agreement approved in an expeditious manner it is only asking for approval of the Agreement at this time.

In addition to the changes made to the Agreement as a result of the Commission's actions in Docket No. 10-35-97, there are a few additional changes specific to Google. The Agreement reflects certain changes to address Google's unique situation of taking over existing pole attachments. Google recently acquired the iProvo network, and will be taking over many existing attachments, rather than simply requesting new attachments as is generally the case with respect to pole attachment agreements.

Lastly, the Agreement reflects changes in the d/b/a name for CenturyLink. This change is a result of CenturyLink Inc.'s acquisition of Qwest Communications International, Inc. that was approved by the Commission in Docket No. 10-049-16.

CenturyLink respectfully requests the Commission approve the attached Agreement.
