NOTICE OF APPLICATION

Pursuant to Utah Code Ann. § 63G-4-201 et seq., notice is given that Qwest Corporation d/b/a CenturyLink QC (“CenturyLink”) filed the above application on July 29, 2013. CenturyLink requests approval by the Utah Public Service Commission (“Commission”) of its petition to modify CenturyLink’s Performance Assurance Plan (“PAP”) and Performance Indicator Definitions (“PID”) consistent with the settlement in Colorado as follows:

1. Approve Exhibits Y (redesigned PAP) and Z (redesigned PIDs) with an effective date of January 1, 2014, to replace the existing PAP and PIDs in Utah; and
2. Deem all existing interconnection agreements that currently contain the PAP and PIDs be modified to incorporate these revisions, also effective January 1, 2014, without need for further filings or approvals.
