Dear Mr. Widerburg:

In accordance with the Public Service Commission of Utah's (the "Commission") Rule R746-405, South Central Utah Telephone Association, Inc. ("South Central") submits for filing the original and two (2) copies of the Service Area Map/Exchange Boundaries for the following South Central Exchanges:

1. Kanab Exchange
2. East Panguitch Exchange
3. South West Panguitch Exchange
4. Bicknell Exchange
5. Marysvale Exchange
6. Apple Valley Exchange
7. Hildale Exchange
8. Hatch Exchange
9. Orderville Exchange.
10. Boulder Exchange
11. Escalante Exchange
12. Beryl Exchange

The Exchange Maps for Kanab, East Panguitch, South West Panguitch, Bicknell, and Marysville have been revised to include areas within South Central's certificated service area which were previously unserved.

The Exchange Maps for Apple Valley and Hildale have been revised to reflect that a service area previously contained in the Hildale Exchange is now contained within, and served from, the Apple Valley Exchange.

The Exchange Maps for Hatch and Orderville have been revised to reflect that a service area previously contained in the Orderville Exchange is now contained within, and served from, the Hatch Exchange.

The Exchange Maps for Boulder and Escalante have been revised to reflect that a service area previously contained in the Escalante Exchange is now contained within, and served from, the Boulder Exchange.

The Exchange Map for Beryl has been revised to reflect that Iron Town is contained within, and served from, the Beryl Exchange. Iron Town was originally an unserved area in Qwest's certificated area, but was acquired by South Central previously. However, the South Central Beryl Exchange Map was not previously updated to reflect this change.

The revised Service Area Maps/Exchange Boundaries reflect the boundaries of the service areas, the principal streets, and the general location of the service area of the applicable South Central Exchanges in relation to nearby cities and major highways as required by R746-405-2(A)(4).

South Central hereby submits the enclosed service area maps pursuant to R-746-405-2(A)(4) and R746-405-2(E)(3) and requests that the Commission waive the 30-day filing requirement and authorize the updated Service Area Maps/Exchange Boundaries filed herewith to become effective immediately, for the reason that the revisions identify and define the existing service area boundaries for the applicable South Central Exchanges. Therefore, an immediate effective date will benefit subscribers and prospective subscribers in inquiries related to service area boundaries in the South Central Exchanges.
