NOTICE OF CONSUMMATION

Dear Mr. Widerbury:

On behalf of TNCI Operating Company LLC (“TNCI-OpCo”) and Trans National Communications International, Inc. (Debtor-in-Possession) (“TNCI-DIP”), this letter notifies the Commission that on December 13, 2013, TNCI-OpCo completed the acquisition of the Utah customers (including the customers’ contracts) and assets of TNCI-DIP as described in the above-referenced Application. As a result of the Transaction, TNCI-OpCo initiated service to TNCI-DIP’s Utah customers pursuant to Certificate No. 2431.

Also as a result of the Transaction, TNCI-DIP no longer provides telecommunications services in Utah. To the extent TNCI-DIP still has a Certificate,¹ TNCI-DIP requests that its Certificate to provide intrastate telecommunications services be canceled, and its tariffs withdrawn effective December 13, 2013 or as soon as the Commission is able to take appropriate administrative action.
