My apologies for the slight delay in response from the Office. My developing circumstances require an additional layer of administrative coordination. For information purposes, I have accepted an employment offer from the state of Colorado and will complete my time with the Utah AG's Office at the end of next week. I have discussed the potential move of the hearing in this matter with my supervisor to ensure that the Office will have representation at the hearing. The Office does anticipate providing a brief statement for the record during any hearing scheduled by the Commission. With respect to the dates proposed for a modified hearing schedule, the Office is amenable to any, with the caveat that availability on August 27 is limited to the afternoon. The Attorney General's Office has assured me that counsel will be provided for the Office during any of these times.

The DPU and Gunnison have reached a stipulation in the Gunnison rate case. We expect to file the Stipulation in the next few days. We would like to move the Hearing date up from September 17, 2014. Justin Jetter and I have discussed dates in August and we can be available August 18th (anytime); August 19th (afternoon); August 26 (any time) or August 27 (any time). It is my understanding that the Office of Consumer Services will not be participating in the hearing. However, in case I am incorrect, and the Office will be participating, I have copied their counsel on this email.
