- 1 A customer must subscribe to the Company's qualifying Long Distance calling plan(s) and High Speed Internet (HSI) Service in conjunction with the Choice Business Plus package. Qualifying Long Distance services are specified in the Qwest LD Corp. tariffs, price lists and rate schedules. Qualifying internet services are specified at www.centurylink.com.
2. In addition to the qualifying services for Core Connect, customers may add Unlimited Business Voice lines on a month-to-month, 1-year, 2-year or 3-year term basis. An Unlimited Business Voice line includes Choice Business Plus as described in 5.9.1.B., preceding, and the Core Connect Unlimited LD calling plan. The Unlimited Business Voice Line requires Core Connect. Effective June 19, 2010, *LINE VOLUME ADVANTAGE* is obsolete and no longer available to new customers. Existing customers with a signed agreement may renew their *LINE VOLUME ADVANTAGE* for one additional term upon the expiration of their current agreement.

A. Description

1. *LINE VOLUME ADVANTAGE* is available to business customers subscribing to 50 or more lines in conjunction with basic business access lines. A customer may have up to a maximum of 3000 participating lines across the Qwest region. *LINE VOLUME ADVANTAGE* is offered as a tiered plan with each tier having a Minimum Line Requirement.
2. *LINE VOLUME ADVANTAGE* may be offered to business customers who are contemplating establishing service with another telecommunications service provider or, business customers currently receiving their service from another telecommunications service provider.
3. *LINE VOLUME ADVANTAGE* defines qualifying lines as the following:
 - Flat Rate Business Lines (1FB) with Hunting
 - *QWEST CHOICE* Business
 - *QWEST CHOICE* Business Plus
 - Add-A-Line
 - *QWEST CHOICE* Business Prime
