COMES NOW the Office of Consumer Services (“Office”) and hereby respectfully requests the Public Service Commission of Utah (“Commission”) suspend the Notice of Comment Period and Notice of Hearing issued May 22, 2014 in the above identified docket. Further, the Office requests the Commission set a Scheduling Conference in order for interested parties to discuss and mutual agree upon a schedule for preparing and submitting comments to the Commission.

On May 21, 2014, the Division of Public Utilities (“Division”) submitted a Petition to the Commission outlining the Division’s belief that Hanksville Telecom, Inc. is eligible for an increase in Universal Service Fund (“USF”) distributions. On May 22, 2014, the Commission issued Notices of Filing, Comment Period and Hearing in this matter. Specifically, the Commission established an initial comment period of 30 days, ending June 23, 2014, as well as a 14 day reply comment period,

ending July 8, 2014. Further, the Commission set a hearing on this matter for July 10, 2014. The Office believes a full, fair and comprehensive evaluation of the Division's Petition will require more time than that provided under the Commission's May 22, 2014, Notices. Accordingly, the Office requests the Commission suspend the May 22, 2014, Notice of Comment Period and Notice of Hearing, and set a scheduling conference at the earliest date convenient to the Commission to allow discussion and to establish a schedule in the matter such that will allow a full, fair and comprehensive evaluation of the issues at hand.
