The Utah Rural Telecom Association (“URTA”), on behalf of itself and URTA members All West Communications, Inc., Bear Lake Communications, Inc., Beehive Telephone Company, Carbon/Emery Telcom, Inc., Central Utah Telephone, Inc., Direct Communications Cedar Valley, LLC, Emery Telephone, Hanksville Telcom, Inc., Manti Telephone Company, Skyline Telecom, South Central Utah Telephone Association, Inc. and Union Telephone Company (“Members” or “URTA Members”) hereby withdraws its Petition to Intervene.

On November 19, 2014, New Horizons Communications Corp. filed a letter with the Utah Public Service Commission clarifying that it is not seeking authority to provide telecommunications services in exchanges in the State of Utah with fewer than 5,000 access lines that are owned or controlled by an ILEC with fewer than 30,000 total access lines. Because New Horizon is not seeking authority to provide services in exchanges with fewer than 5,000 access lines that are owned or controlled by an ILEC with fewer than 30,000 total access lines, URTA withdraws its Petition to Intervene.
