Pursuant to Utah Code Ann. §54-7-1 and Utah Admin. Code r746-100, the Utah Division of Public Utilities (“Division”) submits this Motion to Amend Joint Settlement Stipulation (“Stipulation”) in resolution of this docket and moves the Public Service Commission of Utah (“Commission”) as follows:

PROCEDURAL HISTORY

1. On April 6, 2015, STRATA filed its Application for Increase in Utah Universal Service Fund Support, pursuant to Utah Code Ann. §54-8b-15 and Utah Admin. Code r746-360.
2. On December 15, 2015 the Utah Division of Public Utilities (“Division”), the Utah Office of Consumer Services (“Office”), and UBTA-UBET Communications, Inc. (DBA STRATA Networks) (“STRATA”) (collectively the “Parties”) filed a Joint Settlement Stipulation signed by each of the Parties.

3. On December 15, 2015 a hearing was held and the Parties requested additional time to review certain costs that would be subject to an amendment to paragraph 9 of the Stipulation. Additionally a mathematical error was recognized in paragraph 8 of the Stipulation.

4. In order to recognize the Parties agreement on costs in paragraph 9 and to correct the calculation error in paragraph 8 the Signatories have executed the Amended Joint Settlement Stipulation which reflects the Parties' agreement to include \$75,160 in costs in paragraph 9 and to correct the value of \$141,833.33 to the proper value of \$141,666.66 in paragraph 8.

5. The signatories submit that the terms of the Amended Joint Settlement Stipulation are just and reasonable and otherwise in the public interest and should be approved.

6. WHEREFORE, the Division respectfully requests that the Commission grant this motion and approve the Amended Joint Settlement Stipulation in the form filed with the Commission.
