NOTICE OF APPLICATION

On November 13, 2015, Garrison TNCI LLC; TNCI Operating Company LLC; Impact Telecom, Inc.; and Matrix Telecom, Inc. (Applicants) filed the above application for approval of a restructuring and purchase agreement that will transfer Impact Telecom, Inc. to Garrison TNCI LLC. Therefore, control of Matrix Telecom, Inc., which is a subsidiary of Impact Telecom, Inc., will be indirectly transferred to Garrison TNCI LLC. Thereafter, Applicants propose to change the corporate status of Impact Telecom, Inc. and Matrix Telecom, Inc., operating both entities as limited liability corporations.
