Dear Mr. Gross,

We received your Vitcom LLC Application for CPCN yesterday, along with a disk containing your electronic filing. When I attempted to process your filing, I noticed some discrepancies that need to be addressed before it can be fully processed. First, your Application needs to be filed separately from your exhibits electronically, and must be in Microsoft Word format. Second, you have a list of exhibits, but these are not filed separately electronically, and there is no delineation between them for me to know which exhibit is which. These may be filed in pdf format electronically, but I need them to be designated separately. Third, the exhibits you did file seem to be duplicates of previous material--ie. your profit and loss statement. Fourth, another exhibit, your Price List--Rules, Regulations, and Schedule of Rates and Charges is not listed on your exhibit list. Is it supposed to be "Exhibit G?" Fifth, I am assuming based on filings of similar nature that you do not wish your financial info to be public. Please designate which exhibits (when you send them electronically) are CONFIDENTIAL, and which are not.

We do not require you to re-file your paper copies of your Application. However, before I can process your Application, I need you to email me at psc@utah.gov the completed filing, including Cover Letter, Application (in Word Format), and designated pdf's of each exhibit you would like included with your filing, including which are CONFIDENTIAL.
