ORDER SUSPENDING SCHEDULING ORDER

On April 9, 2015, the Commission issued a Scheduling Order in this docket. On May 29, 2015, the Division of Public Utilities (Division) filed a motion to suspend testimony in this docket because a settlement agreement is imminent. The Division purports no opposition to the motion.

Given that the Division's motion is unopposed, and for other good cause appearing, the Commission suspends the scheduling order entered in this docket. The suspension does not apply to pending or future discovery. If, at a future date, the Division or another party believes reason(s) exist for lifting the suspension, said Division or party should file a motion explaining the reason(s) why it is necessary to lift the suspension.

NOTICE OF HEARING ON SETTLEMENT STIPULATION

A hearing is scheduled for **Tuesday, July 7, 2015, beginning at 10:00 a.m.** The hearing will be conducted by the Administrative Law Judge of the Public Service Commission and **will be held in the Fourth Floor Hearing Room 451**, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. This hearing is being rescheduled at the request of the parties to address the filed settlement stipulation, which is expected to be filed within the next 30 days.

Parties should come prepared to testify as to whether the proposed settlement stipulation is just and reasonable, and in the public interest.
