BACKGROUND

On June 18, 2002, in Docket No. 01-2366-01, the Public Service Commission of Utah (Commission) granted Intrado Communications Inc. (Intrado) a Certificate of Public Convenience and Necessity, authorizing the company to provide public telecommunications services within the State of Utah.

On March 4, 2016, Intrado filed a notice stating that it has changed its name to West Safety Communications Inc. as part of a rebranding and marketing campaign by its parent company, West Corporation.<sup>1</sup> Intrado also filed a price list to reflect the name change.

On March 14, 2016, the Division of Public Utilities (Division) filed a memorandum recommending that the Commission acknowledge the name change.

ORDER

Having reviewed the records, the Commission acknowledges the name West Safety Communications Inc. and amends the affected Certificate of Public Convenience and Necessity

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
