ORDER APPROVING REQUEST TO
WITHDRAW TARIFF FILING

ISSUED: June 5, 2017

On April 24, 2017, Beehive Telephone Company, Inc. (Beehive) filed with the Public Service Commission of Utah (PSC) a request to modify its tariff, increasing the rate for basic service from \$18.00 per month to \$20.00 per month, in order to qualify for continued participation in the FCC's Connect America Fund (CAF) program. Subsequent to Beehive's filing, the FCC determined to freeze the base rate mandated for CAF participation at \$18.00 per month. Therefore, on May 30, 2017, Beehive filed with the PSC an advice letter, requesting leave to withdraw its April 24, 2017 tariff filing.

On June 1, 2017, the Division of Public Utilities filed comments in this docket, recommending that Beehive be permitted to withdraw the tariff filing that, if approved, would have increased its base rate from \$18.00 per month to \$20.00 per month.

ORDER

The PSC grants Beehive Telephone Company Inc.'s May 30, 2017 request to withdraw its April 24, 2017 tariff filing.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
