To the Commission:

In accordance with Utah Code Annotated Section 54-7-12(7) and R746-405 and pursuant to the Public Service Commission's ("Commission's") Rule R746-360-6, and the Commission's Order dated June 7, 2016 in Docket 16-R-360-01, All West Communications, Inc. ("All West") hereby electronically files the following:

1. The 5th Revised Sheet No. 99, canceling the 4th Revised Sheet No. 99 of All West's Local Access Tariff on file with the Commission.

The 5th Revised Sheet No. 99 modifies All West's residential rates from \$18.00 to \$20.00 in conformity with Commission Rule R746-360-6 which requires a telecommunications corporation to charge a minimum of \$20 per line as of July 1, 2017 to be eligible for USF subsidization.¹

Further, under Federal Communications Commission (FCC) rules as of July 1, 2017, all eligible telecommunications carriers that are incumbent local exchange carrier recipients of federal high-cost support must report the number of residential service lines for which the sum of local rates and state fees (as of June 1, 2017) are below the 2016 rate floor for voice service (\$22.49). To the extent that an incumbent local exchange carrier's local rates, plus state regulated fees, are less than \$20 as of June 1, 2017, that carrier's high-cost federal support will be reduced. As a result, All West requests an effective date for the rate increase of June 1, 2017 to meet the federal rate floor.

¹ A minor modification to properly reflect the tariff number and the revision number is also contained in the 5th Revised Tariff Sheet No. 99. This corrects an error in the previously revised Sheet No. 99.

The tariff sheet as proposed does not constitute a violation of state law or Commission rule. All West respectfully requests, in accordance with R746-405-2(E)(3), that the Commission waive the thirty (30) day notice period and that the Revised Tariff Sheet No. 99 become effective June 1, 2017.
