NOTICE OF TECHNICAL CONFERENCE

ISSUED: May 9, 2018

On December 21, 2017, the Public Service Commission of Utah ("PSC") issued a Notice of Comment Period ("Notice") to investigate the revenue requirement impacts of the new federal tax legislation ("Tax Reform Act"). The PSC requested that all regulated utilities in Utah file comments describing in detail, to the extent practical, the impacts of the Tax Reform Act on their respective revenue requirement in the corresponding docket. In comments filed in these dockets by the Division of Public Utilities ("DPU") on March 30, 2018, the DPU noted that evaluation of the telecom revenue requirement should be made with consideration of all of the changes associated with the Tax Reform Act, the changes to Utah Code Ann. § 54-8b-15, and the newly enacted and proposed administrative rule changes collectively. Most of the telecom utilities listed in these dockets have requested the PSC hold a technical conference to consider these issues.¹
