NOTICE OF FILING

On June 8, 2017, West Corporation, West Safety Communications Inc., and Olympus Holdings II, LLC notified the Public Service Commission of Utah of a proposed transaction whereby Olympus Merger Sub, Inc. (a wholly owned subsidiary of Olympus Holdings II, LLC) will acquire ultimate control of West Corporation and West Corporation's wholly owned subsidiaries, one of which is West Safety Communications Inc. The parties consider that the transaction is not subject to Utah Code § 54-4-28.
