ORDER APPROVING REQUEST TO
WITHDRAW TARIFF FILING

ISSUED: June 20, 2017

On June 1, 2017, Direct Communications Cedar Valley, LLC (Direct Communications) filed with the Public Service Commission of Utah (PSC) a request to modify its tariff so as to implement rates that exceed the PSC-approved affordable base rate.

On June 14, 2017, the Division of Public Utilities (Division) filed comments in this docket, recommending that the proposed tariff modifications should not be approved. In its comments, the Division noted that there is no present requirement to raise local residential rates above the \$18 affordable base rate currently approved by both the PSC and the Federal Communications Commission. The Division also stated that Direct Communications had indicated a willingness to withdraw this tariff filing and, instead, submit a request to establish rates that comply with the Utah affordable base rate.

On June 19, 2017, Direct Communications filed the anticipated request to withdraw.

ORDER

The PSC grants Direct Communications Cedar Valley, LLC's June 19, 2017 request to withdraw its June 1, 2017 tariff filing.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
