On August 30, 2018, the Division of Public Utilities (“DPU”) filed a Motion to Vacate Remaining Schedule and Request to Schedule Hearing on Stipulation for September 12, 2018 (“Motion”). The DPU represents the parties have executed a settlement agreement, filed with the Public Service Commission (“PSC”) on August 30, 2018, and requests the PSC vacate the remaining adjudication schedule and set the docket for hearing on September 12, 2018 for the purpose of presenting evidence in support of the settlement agreement.

The DPU represents all parties have either signed the settlement agreement or do not oppose it.

Good cause appearing, the Motion is granted. The remaining adjudication deadlines established in the PSC’s Scheduling Order, issued March 20, 2018, are vacated.
