The original of this notification, along with Utah Department of Commerce documentation is submitted on behalf of Cincinnati Bell Any Distance, Inc. ("CBAD" or "Company") to notify the Commission of a change in the Company name. CBAD received a Certificate of Public Convenience and Necessity to provide interexchange services within the State of Utah on January 5, 2004 and local exchange service on February 7, 2012.

Through a series of Delaware and Utah Department of Commerce transactions, effective October 25, 2017, CBTS Technology Solutions LLC filed, and the Utah Division of Corporations and Commercial Code accepted, an Amendment to Authority to Conduct Affairs for a Foreign Corporation to update the company's name on the Utah records from Cincinnati Bell Any Distance Inc. to CBTS Technology Solutions Inc. Effective October 26, 2017, CBTS Technology Solutions LLC filed, and the Utah Division of Corporations and Commercial Code accepted, Articles/Statement of Conversion and a Foreign Registration Statement, to change its entity type to a foreign limited liability company and its name to CBTS Technology Solutions LLC on the records of Utah.

The name change and change in form will have no customer impact. A customer notice in the form of a bill message is being provided to all customers stating: "Cincinnati Bell Any Distance Inc. has converted to a limited liability company and changed its name to CBTS Technology Solutions LLC. This change does not affect your service or rates, including any of your rights or obligations
