**7.4 Miscellaneous Long Distance Services**

Long Distance Only Monthly Recurring Charge: \$4.95  
A customer will be billed a monthly recurring charge when they do not subscribe to local services and only have long distance services with Birch.

Long Distance Only Monthly Minimum: \$4.95  
Each customer that does not subscribe to local services and only has long distance services with Birch will be billed a minimum per month per account of \$4.95 for long distance services. If monthly charges for outbound usage equal or exceed \$4.95 in a billing period, the monthly minimum will not apply. If the monthly minimum charge in a billing period is less than \$4.95, the monthly minimum usage charge that will apply will be the difference between the month's usage charge and \$4.95. This charge is in addition to any applicable Monthly Recurring Charge.
