("Members" or "URTA Members"), together with the Division of Public Utilities (the

"Division") and the Office of Consumer Services (the "Office") (collectively the "Parties")

hereby jointly request additional process in these dockets as permitted by the Scheduling Order issued by the Commission on October 12, 2018.

First, the Parties agree that a third round of Comments would permit the Parties to more fully respond to the issues raised by the other Parties and would allow the Parties to fully

develop the issues for the Commission. As a result, the Parties hereby request that the Scheduling Order be amended to provide for another round of Comments to be filed on November 29, 2018.

Second, the Parties have met and conferred on the excess deferred income tax (EDIT) issue including the method for "pay back" of the EDIT where it cannot offset UUSF. The Parties believe that the additional two weeks granted above for additional comments will permit the parties to reach a consensus on this issue. To the extent a consensus has been reached, the Parties can report such consensus in the third round of comments to be filed November 29, 2018. If the parties have not reached a consensus on this issue, the parties can request a scheduling order to request further process on that issue. The EDIT issue does not impact the UUSF determinations/recommendations and will not require any interim rates.

Third, the Parties believe that additional time and separate process may be required by the Union Telephone Company Comments. Once reply Comments have been filed, the Parties will have better understanding of the issue and can either address those issues in the third round of comments requested herein, or request a scheduling conference with the Commission to request further process on this issue.

Finally, it is the Parties understanding that the Division anticipates utilizing feedback from the Commission orders to make revised recommendations for UUSF. The Parties believe a more specific schedule for this process would be helpful.

#### **CONCLUSION**

The Parties hereby request that the current Scheduling Order be amended to allow the Parties the opportunity to file an additional round of Comments on the issues raised in these

dockets on or before November 29, 2018. If there are issues that require further process, the Parties will request a Scheduling Conference with the Commission to schedule such further process.
