ORDER GRANTING MOTION TO AMEND HEARING DATE, GRANTING LEAVE FOR WITNESS AND COUNSEL TO APPEAR TELEPHONICALLY, AND AMENDED NOTICE OF HEARING

ISSUED: October 12, 2018

On April 23, 2018, the Public Service Commission (“PSC”) issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. The Scheduling Order established a hearing date of December 11, 2018. Settlement discussions have taken place among some of the parties to this docket, and on October 3, 2018, Virgin Mobile, the Division of Public Utilities (“DPU”), and the Office of Consumer Services (“OCS”) (collectively, “Joint Parties”) filed a Stipulation and Settlement Agreement. On October 10, 2018, Virgin Mobile USA, L.P. (“Virgin Mobile”) filed a Motion to Amend Hearing Date and Request Leave for Witness and Counsel to Appear Telephonically (“Motion”). Virgin Mobile is requesting the hearing date be amended to October 22, 2018 and represents the Joint Parties support the Motion. Virgin Mobile states the Utah Rural Telecom Association (a party granted intervenor status in this docket) has been provided notice of the Motion and has no objection to the amended hearing date. Accordingly, the PSC gives notice the hearing date of December 11, 2018, established in the Scheduling Order, is vacated.

In its Motion, Virgin Mobile further requests the PSC allow Virgin Mobile’s witness and counsel to appear telephonically at the hearing.

There being no objection, and good cause appearing, the Motion, in its entirety, is granted.

AMENDED NOTICE OF HEARING
