Re: i-wireless, LLC Notice of Lifeline Rate Changes

Dear Sir/Madam:

i-wireless, LLC (“i-wireless”) was designated as an Eligible Telecommunications Carrier (“ETC”) in Utah in Docket No. 10-2526-01 and was authorized to participate in the Utah Universal Service Fund (“USF”) in Docket No. 18-2526-01. i-wireless hereby provides notice of changes to its Lifeline offering effective December 1, 2020 in accordance with changes in the Federal Communications Commission’s minimum service standards.<sup>1</sup>

As summarized in Attachment A attached hereto, new customers and existing customers who have a smart device receive the updated Broadband Bundle with 1,250 voice minutes, unlimited text messages and 4.5 gigabytes (GB) of data at no cost after application of enhanced tribal Lifeline and Utah USF support. Existing customers without a smart device will retain their existing benefits which meet voice-only minimum service standards.

i-wireless has also added an enhanced tribal offering which provides eligible residents of federally-recognized tribal lands within i-wireless’ existing ETC service area with unlimited voice minutes, unlimited text messages and 5.5 GB data at no cost after application of enhanced tribal Lifeline and Utah USF support.

The Order waived the Lifeline minimum mobile broadband service standard to the extent it would require mobile carriers in the Lifeline program to offer more than 4.5 GB per month, but did not pause the scheduled phasedown of support for Lifeline voice service.
