ISSUED: October 22, 2018

On May 22, 2018, the Public Service Commission (“PSC”) issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. On September 17, 2018, the PSC issued an order (“Order Amending Schedule”), granting the Division of Public Utilities’ (“DPU”) Motion to Amend Schedule and amending the deadlines for filing of non-applicant direct testimony, rebuttal testimony, and surrebuttal testimony. The Order Amending Schedule left other dates established in the Scheduling Order, including the hearing date, unchanged.

On October 22, 2018, the Office of Consumer Services (“OCS”) filed a Motion to Amend Schedule (“Motion”), representing the parties are engaged in settlement discussions and require additional time to submit non-applicant direct testimony. The Motion requests the due date for non-applicant direct testimony be amended from October 23, 2018, as established in the Order Amending Schedule, to November 15, 2018. The OCS represents the DPU and Assist Wireless, LLC support the Motion and intervenor Utah Rural Telecom Association does not oppose it.

Good cause appearing, the Motion is granted. Written direct testimony for parties other than the applicant shall be due **Thursday, November 15, 2018**. The hearing date remains set, on December 12, 2018, as noticed in the Scheduling Order.
