ISSUED: November 21, 2018

As previously noticed in the Public Service Commission's ("PSC") Scheduling Order and Notice of Hearing ("Scheduling Order"), issued May 22, 2018, this docket is set for hearing on December 12, 2018 at 9:00 a.m. On November 13, 2018, the parties filed a Stipulation and Settlement Agreement ("Settlement"). On November 15, 2018, the Division of Public Utilities ("DPU") filed a Memorandum, recommending the PSC vacate the remaining deadlines for the submission of written testimony as enumerated in the Scheduling Order.

The PSC notes the DPU's recommendation is not expressly endorsed or joined by the other parties. Because the DPU's recommendation is not joined by the other parties, the PSC will not issue an order modifying the Scheduling Order absent an opportunity for other parties to respond to a proper motion to amend the Scheduling Order. However, the parties should understand the testimony deadlines in the Scheduling Order are not mandates that require a party to submit written testimony but simply the date by which a party who elects to submit written testimony must do so. The PSC further notes that the deadline for direct testimony of non-applicants was November 15, 2018, and no party filed testimony. If any party believes the deadlines outlined in the Scheduling Order should be reconsidered or amended, the party may file a motion.
