ORDER GRANTING MOTION  
TO AMEND SCHEDULE

ISSUED: December 13, 2018

On October 4, 2018, the Public Service Commission of Utah (“PSC”) issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. In part, the Scheduling Order established December 18, 2018 as the deadline for parties other than Viasat Carrier Services, Inc. (“Applicant”) to file direct testimony, and January 8, 2019 as the deadline for parties to file rebuttal testimony.

On December 12, 2018, the Division of Public Utilities (“DPU”) filed a motion to amend the Scheduling Order (“Motion”). In its Motion, the DPU indicates some parties to this docket have been involved in ongoing discussions and the DPU requests additional time to pursue a settlement prior to filing its direct testimony. The DPU further represents that the Office of Consumer Services and the Applicant support its Motion, and that intervenor Utah Rural Telecom Association has been provided notice and does not object.

Good cause appearing, the Motion is granted. Parties other than the Applicant may file direct testimony on or before **Tuesday, January 8, 2019**, and parties may file rebuttal testimony on or before **Monday, January 14, 2019**. All other deadlines and the hearing date established in the Scheduling Order remain unchanged.
