Petition of Viasat Carrier Services, Inc. for Designation as an Eligible Telecommunications Carrier to Receive Connect America Fund Phase II Auction (Auction 903) Support for Voice and Broadband Services

ORDER APPROVING STIPULATION AND SETTLEMENT AGREEMENT

ISSUED: February 13, 2019

On September 26, 2018, Viasat Carrier Services, Inc. (“Viasat”) filed its Petition for Limited Designation as an Eligible Telecommunications Carrier to Receive Connect America Fund Phase II Auction Support for Voice and Broadband Services (“Petition”). In the Petition, Viasat seeks eligible telecommunications carrier (“ETC”) designation.

On January 22, 2019, the parties filed a Stipulation and Settlement Agreement (“Settlement”), signed by the Division of Public Utilities (“DPU”), the Office of Consumer Services (“OCS”), and Viasat (collectively, the “Parties”). On January 23, 2019, the Public Service Commission (“PSC”) held a hearing to consider the Settlement, during which Viasat, the DPU, and the OCS provided testimony.

In the Settlement, the Parties stipulate and agree Viasat’s voice and broadband offerings will meet the Federal Communications Commission’s Connect America Fund Phase II support requirements. The Parties further agree said services represent a benefit for Utah customers, are in the public interest, and further the statutory goal that such services be available and affordable to all citizens of Utah. The Parties specifically “stipulate and agree that designating Viasat [as] an ETC for the price cap areas of the census blocks identified in Exhibit A to the Petition serves the public interest, convenience and necessity.” (Settlement at 5.)

The Settlement provides that, as a condition of receiving State designation, Viasat will offer all of the required supported services set forth in 47 C.F.R. § 54.101(a). The Parties agree Viasat has shown an intent and ability to offer those services once designated throughout its requested service areas. The Parties stipulate to additional requirements as enumerated in the Settlement, including but not limited to Viasat's use of a Utah-specific fact sheet, Viasat's compliance with applicable regulations, and its payment of applicable state and local regulatory fees.

At hearing, the OCS testified it believed the Settlement to be just and reasonable in result and that approval of the Settlement is in the public interest. Similarly, the DPU testified it believed approval of the Settlement to be just, reasonable, and in the public interest. No party opposed the Settlement.

FINDINGS, CONCLUSIONS AND ORDER

Settlements of matters before the PSC are statutorily encouraged. To approve a settlement, the PSC must consider the interests of the public and other affected persons and find the settlement is just and reasonable in result. Utah Code Ann. § 54-7-1.

Based on our consideration of the Petition, the submitted written testimony, the testimony at hearing, and the Settlement, the PSC finds and concludes that approval of the Settlement is in the public interest and that the terms of the Settlement are just and reasonable in result.

The PSC, therefore, approves the Settlement and grants the Petition, as conditioned and supplemented by the Settlement.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
