The above referenced dockets — Nos. 19-041-01 ("Sorrel Docket"); 19-041-02 ("May Docket"); and 19-041-04 ("Investigation Docket") — all arise out of concerns with Frontier Communications' quality of service in or around Castle Valley, Utah. On May 24, 2019, at the parties' request, the Public Service Commission (PSC) consolidated proceedings in the Investigation Docket and the May Docket.

On August 8, 2019, SRR Partners, LLC ("SRR") filed a Status Report and Motion to Consolidate in the Sorrel Docket ("Motion"), moving the PSC to consolidate the Sorrel Docket with the two previously consolidated dockets. SRR represents "it would be more efficient and effective to consolidate the . . . dockets." (Motion at 1.) On August 23, 2019, the Office of Consumer Services filed a Response in Support of Motion to Consolidate ("Response"), representing that "administrative efficiency would be served by consolidating all [three] proceedings." (Response at 1.) No party has opposed the Motion.

Therefore, there being no opposition and good cause appearing, the Motion is granted. The adjudication of the Sorrel Docket is consolidated into a single proceeding with the May and
