ISSUED: May 29, 2019

On April 15, 2019, South Central Utah Telephone Association, Inc. ("SCUTA") filed Advice Letter No. T-19-052-T01, proposing revisions to its Local Tariff ("Tariff"). SCUTA requested an effective date of May 14, 2019 for these Tariff modifications. SCUTA's filing generally proposes to (1) clean up outdated tariff sheets; (2) add new service offerings; and (3) delete services where there are no customers.

On April 15 and May 6, 2019, the Public Service Commission ("PSC") issued action requests to the Division of Public Utilities ("DPU"). On May 8, 2019, the DPU filed a request for an extension of time until June 30, 2019 to respond to the action requests. As a result of SCUTA's communications with the DPU, on May 8, 2019, SCUTA filed corrected Tariff Sheet Nos. 22 and 23.

On May 13, 2019, the PSC issued a notice granting the DPU's request for an extension of time and an order suspending the Tariff changes SCUTA requests in this docket. On May 17, 2019, SCUTA filed updated tariff sheets and proposed an effective date of May 31, 2019 for the Tariff changes.

On May 20, 2019, the DPU filed comments describing the reasons for the filing (original and updated) and concluding SCUTA's proposed rates for new services appear to be just and reasonable. The DPU states that SCUTA is a telephone cooperative and is adhering to the requirements for introducing new services as specified in Utah Code Ann. § 54-7-12(7). The

DPU recommends the PSC approve SCUTA's Tariff revisions with an effective date of May 31, 2019.
