On February 1, 2019, Olympus Holdings II, LLC, the parent company of West Corporation (“West”) and AP VIII Olympus VoteCo, LLC (“Olympus VoteCo”), filed with the Public Service Commission of Utah (“PSC”) a notice they have entered into and intend to consummate a transaction whereby Olympus VoteCo will acquire ultimate control of West and West’s wholly owned subsidiaries, including West Safety Communications Inc., a telecommunications corporation authorized to provide facilities-based and resold competitive local exchange telecommunications services in the State of Utah.
