MOTION TO MODIFY SCHEDULE

Global Connection Inc. of America d/b/a STAND UP WIRELESS (“Applicant”), by counsel, respectfully moves the Public Service Commission of Utah (“Commission”) to modify the schedule set forth in the May 13, 2019 Scheduling Order and Notice of Hearing (“Scheduling Order”) to amend the deadline for Applicant’s direct testimony to June 21, 2019.

During the scheduling conference on May 9, 2019, the parties stipulated to the schedule adopted by the Scheduling Order. Due to unforeseen and extended medical leave by counsel, Applicant was unable to meet its direct testimony deadline of May 30, 2019. Applicant therefore seeks an amended direct testimony deadline of June 21, 2019, which still allows for almost eight (8) weeks until the next deadline of August 15, 2019 for direct testimony of parties other than applicant. Thus, all other deadlines set forth in the Scheduling Order would remain unchanged.
