Mitel Cloud Services, Inc. (f/k/a Mitel NetSolutions, Inc., "Mitel" or "the Company"), through undersigned counsel, hereby requests that the Public Service Commission of Utah cancel its Certificate of Public Convenience and Necessity ("CPCN") – granted in Docket No. 07-2480-01 on 7/25/2007 - and withdraw any applicable tariffs, effective as soon as possible.

Mitel's business model has continued to evolve and develop since the CPCN was originally granted. Today, the Company serves its customers through VoIP and a variety of nomadic interconnected services as well as private business communication and collaboration solutions. Therefore, the CPCN granted by the Commission is no longer necessary. Mitel will, however, continue to offer and provide VoIP services to customers throughout Utah in the future.

The public convenience and necessity will not be adversely affected by the action described herein. Mitel asserts that there are no customers whose service would be impacted by this cancellation. No customer is currently receiving regulated telecommunications services from the Company, and therefore, no customer will have service interruptions or disconnections. Mitel no longer provides regulated telecommunications services under its CPCN in Utah and has not offered such services for several years.

All services offered by the Company are sold on a non-tariffed basis pursuant to individually negotiated commercial agreements with sophisticated business customers. Mitel does not serve any residential or mass market consumers.

To the best of its knowledge, the Company is current on all reporting and fee remittance obligations.

Mitel acknowledges that by signing this Application, Mitel and its successors understand and agree that, to the extent any of the following applies:

- a. Filing the Application does not, by itself, constitute authority to discontinue any service;
- b. Discontinuance shall occur as ordered by the Commission;

c. Mitel will assist in the porting of any assigned telephone numbers to a replacement provider.

Wherefore, Mitel hereby requests cancellation or withdrawal of its Utah CPCN and tariffs as soon as the Commission can take appropriate administrative action.


