Pursuant to Utah Admin. Code r.746-1, the Division of Public Utilities (Division) files this Stipulation and Motion to Amend Schedule. The Division submits the attached Stipulation and requests that the Public Service Commission (Commission) set a hearing date on the Stipulation for May 13th, 2021.

The Commission set a schedule for this docket in its September 30, 2020 Notice of Filing and Comment period. The Commission granted additional scheduling modifications and held multiple status update meetings in lieu of setting filing deadlines. Direct Communications Cedar Valley, LLC (DCCV) and the Division have reached a Settlement Stipulation that is attached to this Motion. The Utah Office of Consumer Services has participated in discussions with the Division and DCCV and is not a signatory to the Settlement Stipulation but does not oppose. A

Confidential Settlement Stipulation along with signature pages is attached to this filing as well as a redacted non-confidential copy.

The Parties have discussed dates and times for a hearing on the Stipulation and the Division requests that a hearing be set for this matter on May 13<sup>th</sup> if that date is available on the Commission's Schedule.

The Division is unaware of any opposition to this Motion or the attached Stipulation. Because the hearing date proposed is sooner than the standard motion practice period and the motion is expected to be unopposed, the Division respectfully requests expedited treatment.
