Pursuant to Utah Code §54-4a and Admin. Code r.746-1, the Division of Public Utilities (“Division”) files this Stipulated Settlement Agreement and Motion to Amend Schedule. The Division, Utah Office of Consumer Services (“Office”) and Sage Telecom Communications LLC d/b/a TruConnect (“Sage Telecom”) collectively (“Parties”) have entered into a settlement stipulation and seek approval by the Public Service Commission of Utah (“Commission”). The Parties also request that the remaining schedule be vacated and an amended hearing date be set for August 3, 2020.

On April 16, 2020 Sage Telecom file a Petition to Amend its Designation as an Eligible Telecommunications Carrier in the State of Utah to Participate in Utah Universal Service Fund. The Commission filed an Action Request on April 16, 2020 to the Division and subsequently

noticed a telephonic scheduling conference. A telephonic scheduling conference was held on April 24, 2020. The Parties agreed to a schedule and a Scheduling Order and Notice of Hearing was issued by the Commission on April 28, 2020. Sage Telecom filed Direct Testimony on April 30, 2020.

The Parties have engaged in good faith negotiations and have reached a settlement agreement attached to this filing. The Division requests that the Commission vacate the remaining filing deadlines set in the April 28, 2020 Scheduling Order and an amended hearing date be set for August 3, 2020.

The Division has provided a copy of this Motion to the Office and Sage Telecom and has been authorized to represent that each of the parties support this motion. The Division is not aware of any opposition to the Motion.
