On September 23, 2020, the Public Service Commission (PSC) issued a Notice of Filing and Comment Period in this docket, setting October 22, 2020 as the deadline for filing comments on Arcadian Infracom 1, LLC's ("Arcadian") application, and November 6, 2020 as the deadline for filing reply comments. On October 22, 2020, the Division of Public Utilities (DPU) filed a Motion for Extension of Time to File Action Request Response and Amend Schedule ("Motion"). The DPU states it held discussions with Arcadian regarding Arcadian's proposed service offerings and requests an extension of time to file comments in this docket. The DPU requests the deadlines for filing comments and reply comments in this docket be amended to October 29, 2020 and November 13, 2020, respectively.

Good cause appearing, the Motion is granted.

AMENDED NOTICE OF COMMENT PERIOD

Any interested person may submit comments on Arcadian's application no later than **Thursday, October 29, 2020**, and reply comments on or before **Friday, November 13, 2020**. If no comment is filed in opposition to the application, the PSC will adjudicate this docket informally and without hearing. *See* Utah Code Ann. § 54-8b-3.
